Mayor Jackson called the meeting to order.

Approval of Minutes

Commissioner Barnes made a motion to approve minutes as presented. The motion was seconded by Commissioner Daigneault. The motion carried unanimously.

1. Robert Hollis of 371 Queen St. discussed the possibility of having a Maker Station Workshop in Grifton. This gives the public an educational opportunity to learn how to build computers and repair software. He has done some research on this topic and discovered that Grifton probably shouldn't invest in a workshop but there is a location in Greenville that offers a Maker Station for a fee of 200.00 a month. He mentioned that the Department of Labor offers grants.

Discussion/Action Items

1. Proclamation declaring Human Trafficking Awareness and Prevention Month – Melisa Simpson shared that it is imperative that we educate our communities, our young people and our families to take an active interest in learning how to recognize the risk and resist predators. It is a global and national problem with North Carolina being consistently ranked among the top ten states for prevalence in human trafficking. Our community must hold accountable those people who purchase sex and those people who look the other way.

On a motion of Commissioner Barnes, seconded by Commissioner Kennedy, that this be allowed. Motion carried unanimously to approve.

2. Ordinance for "No Stopping, Parking, or Standing on N. Highland Blvd." Commissioner Barnes ask if it was already against the law to do so, does it need to be an ordinance also. Manager Mark Warren shared that he called NCDOT District Engineer and they said if you want signs installed out there then we must adopted an ordinance. Upon adopting this ordinance, the signs can be installed.

On a motion of Commissioner Kennedy, seconded by Commissioner Gay, that this be allowed. Motion carried unanimously to approve.

3. Authorize public hearing for Economic Development Incentive Grant Agreement for Food Pride.

On a motion of Commissioner Barnes, seconded by Commissioner Daigneault, that this be allowed. Motion carried unanimously to approve. Commissioner Daigneault asked where the money would come from. Manager Mark Warren said that it would come out of our budget and would be a reduction in revenues that we would have to account for when we work on next year's budget. Commissioner Oakes asked if the sales tax revenue would help with the budget. Manager Mark Warren said it may, but we don't know until we look at the entire picture.

4. Adoption of American Rescue Plan Policies required by Coronavirus State and Local Fiscal Recovery Funds and American Rescue Plan Act of 2021.

On a motion of Commissioner Barnes, seconded by Commissioner Gay, that this be allowed. Motion carried unanimously to approve.

5. Budget Amendment – Police Department & Building & Grounds. Manager Mark Warren explained that the miscellaneous Revenue would be moved to the proper accounts. Building and Grounds are the bank proceeds from the lawn mowers that were purchased and the Police Dept. from the Insurance proceeds for purchase of a vehicle. This will balance the two-line items.

On a motion of Commissioner Barnes, seconded by Commissioner Kennedy, that this be allowed. Motion carried unanimously to approve.

Commissioner Comments

Commissioner Barnes expressed that he was glad to see the Food Pride opened for business. Also said it was nice to see the Christmas tree up at the Town Commons.

Commissioner Daigneault said that she went to the Shad Drop and would like to thank the committee for a wonderful event.

There being no further business Commissioner Barnes made a motion to adjourn. The motion was seconded by Commissioner Gay.
