

ADVERTISEMENT OF TAX LIENS ON REAL PROPERTY - TOWN OF GRIFTON

Under and by virtue of the authority vested in me by Section 105-369 of the North Carolina General Statutes and pursuant to an order of the Board of Commissioners of the Town of Grifton, I am hereby advertising tax liens for the year 2022 upon the real estate described below. The amount advertised will be increased by interest and cost, and the omission of interest and cost from the amount advertised will not constitute a waiver of the taxing unit's claim for these items. The real estate that is subject to the lien, the name of the person to whom the property is listed for taxes, and the principal amount of the taxes are set out below. If the taxes remain unpaid, the lien will be subject to attachment, garnishment, and foreclosure by the taxing unity to satisfy the taxing units claim for taxes.
